The family dispersed and Cary had uncles who served in the frontier US Cavalry and the Canadian North-West Mounted Police. The name Joyce is a contemporary given-name used for females and rarely used for males. As a family-name, it derived from the Old French Masculine name Josse, which derived from the Latin name Iudocus, the Latinized form of the Breton name Judoc meaning "lord".
