Number 553 - Tax on a Child's Investment and Other Unearned Income (Kiddie Tax)

The following two rules may affect the tax and reporting of the unearned income of certain children: Form 1098-T, Tuition Statement. When figuring an education credit, use only the amounts you paid and are deemed to have paid during the tax year for qualified education expenses. In most cases, the student should receive Form 1098-T from the eligible educational institution by January, Other Form Resources.
